

As the primary source of Environment and Natural Resources (ENR) data/information, DENR needs to provide reliable statistics on the ENR situations in the country. The relevant figures and information are of great use to planners, policy makers and researchers for formulation of policies, plans and programs.

# **Executive Summary**

The Department of Environment and Natural Resources is tasked to formulate and implement policies, guidelines, rules and regulations relating to environmental management and pollution and control. It formulates, implements and supervises the government's policies, plans and programs pertaining to the management, conservation, development, use and replenishment of the country's natural resources and ecological diversity. DENR also promulgates and implements rules and regulations governing the exploration, development, extraction, disposition, and use of forests, lands, minerals, wildlife and other natural resources.

The Surigao del Sur Environment and Natural Resources Statistical Profile covers the Demographic as well as the lands, biodiversity, forestry and water sectors in a tabular data and information.

The data provided herein well support planning and decision making not only within the Province but also of other stakeholders such as the Local Government Unit in their provincial and municipal planning.
